

Resolution for Electors to exceed the Levy Limits at a Special Town Meeting of the Electors – 2006 Collected in 2007

Whereas, this Special Town Meeting of the electors has been called and noticed to consider the adoption of a resolution to endorse the town board's resolution to exceed the state levy limits; specifically by increasing the town tax levy for 2006 (collected in 2007) by 8.231% increase over the last year's levy (as calculated and documented by the Wisconsin Department of Revenue)

Now, therefore, the Special Town Meeting of the Town of Union, Burnett County, Wisconsin, by a majority vote of the eligible electors voting on this 21st day of November, 2007 duly assembled and voting resolves and orders as follow:

BE IT RESOLVED, the town electors of the Town of Union, Burnett County, Wisconsin endorse the town board resolution to increase the town levy for 2006 (collected in 2007) by 8.231% over the 2006 town tax levy limit (as calculated and documented by the Wisconsin Department of Revenue), which is an increase of \$8,137.00 over the 2006 town tax levy (as calculated and documented by the Wisconsin Department of Revenue) for a total town tax levy of \$106,989.00 for 2007.

The town clerk shall properly post or publish this resolution as required by law under Sec. 60.80 of Wisconsin Statutes within 30 days of the below noted adoption date.

Adopted this 21st day of November, 2007 at a Special Town Meeting held at the Union Town Hall.

Resolution of Union Town Board to Propose Exceeding Levy Limits – 2006 Collected in 2007

Whereas, the Town Board of the Town of Union, Burnett County believes for the 2006 tax levy (collected in 2007) it is in the town's interest to exceed the state levy limit by 8.231 % over the levy limit (as calculated and documented by the Wisconsin Department of Revenue) for a total tax levy of \$106,989.00.

Now therefore the Town Board of the Town of Union, Burnett County does hereby **RESOLVE** and **ORDERS** as follows:

1. The town board hereby supports an increase in the town tax levy for 2006 (collected in 2007) to exceed the state levy limit (as calculated and documented by the Wisconsin Department of Revenue).
2. The town board directs that the question of increasing the town tax levy for 2006 (to be collected in 2008) by 8.231 %, which would result in a total town tax levy of \$106,989.00 for 2006. This order will be placed on the agenda for the Special Town Meeting to be held on November 21, 2007.
