

**Town of Union
Regular Board Meeting
December 20, 2025
Union Town Hall**

Bob Savage, Chair, called the Regular Town Board meeting to order at 5:00 p.m.

Motion by Dan Waldhauser/Eugene Sikorski to approve the agenda for the meeting. Motion carried 3-0.

Motion by Dan Waldhauser/Eugene Sikorski to approve the minutes of Budget Hearing Meeting, November 17, 2025. Motion carried 3-0.

Motion by Eugene Sikorski/Dan Waldhauser to approve the minutes of Special Town Electors Meeting, November 17, 2025. Motion carried 3-0.

Motion by Eugene Sikorski/Dan Waldhauser to approve the minutes of the Regular Board Meeting, November 17, 2025. Motion carried 3-0.

Motion by Dan Waldhauser/Eugene Sikorski to approve the November 2025 Treasurer's report. Motion carried 3-0.

Motion by Dan Waldhauser/Eugene Sikorski to pay the December bills as presented. Motion carried 3-0.

Bob Savage, Chair, gave the board an update on the snow/tree removal for N River Road. The first snowstorm in November caused severe tree damage to the area and the road could not be plowed until the trees were removed. Moser & Smiley Tree Service worked for 3 ½ days to clean it up.

The next meeting of the OCC is scheduled for January 14, 2025, at 6:15 p.m., Oakland Town Hall.

Steve Herman addressed the board to discuss the public landing at Bass Lake. The Bass Lake Association proposes installing a concrete landing and cleaning station and to assume responsibility for ongoing maintenance of the area. They are coordinating details with the DNR and have committed to funding the project as well as providing comprehensive insurance coverage. Mr. Herman requested that the Township supply class five gravel to repair the road leading to the landing. Bob Savage responded by asking Mr. Herman to submit finalized plans to the board for approval once they are prepared.

Kim Johnson, Clerk, explained to the board 2025 Wisconsin Act 7: Clerk/Treasurer Appointment. The law was passed December 10, 2025, and no longer requires a municipality to go to referendum should they decide to make the positions of Clerk/Treasurer appointed rather than elected.

Motion by Dan Waldhauser/Eugene Sikorski to approve Resolution 2025-1: Election Inspectors, amending Resolution 2007 12-19. Motion carried.

Motion by Eugene Sikorski/Dan Waldhauser to approve the 2026-2027 Elections workers as presented. Motion carried.

Dan Waldhauser, Supervisor, noted concerns regarding residents who plow their driveways and deposit snow across the road onto neighboring properties, resulting in accumulated snow on the roadway and on others' land. He inquired about the township's procedures for addressing such matters. Bob Savage recommended initially approaching the individuals to discuss the issue; if it persists, he advised that the township consider further action.

Kim Johnson, Clerk, discussed an upcoming meeting of the Wisconsin Towns Association in March. She mentioned she felt the meeting would be beneficial for herself, Jayne Schwartz and Jackie Savage. The cost of the meeting is approximately \$67 per member.

Motion by Eugene Sikorski/Dan Waldhauser to approve Kim, Jayne and Jackie attending the Wisconsin Towns Association meeting. Motion carried.

Motion by Eugene Sikorski/Dan Waldhauser to adjourn the Regular Town Board meeting of December 17, 2025, at 5:17 p.m. Motion carried 3-0.
